One such program is Arizona''s Energy Equipment Property Tax Exemption, under which renewable electric generation, including solar thermal electric, photovoltaics, landfill gas, wind and biomass is not considered by the state to add. In addition, solar and wind-energy-generating equipment are exempted from sales tax.

Tax Incentives for Renewable Energy Arizona offers a variety of tax incentives for individuals and businesses for the manufacturing and use of renewable energy products. These tax incentives fall into the categories of Transaction Privilege Tax (TPT; commonly called the sales tax) exemptions and reductions in the amount of income and

The second ensures your property taxes will not increase following the installation of a solar system on your home.

Hog fuel is fully exempt from sales tax, though the buyer must provide the seller a completed sales tax exemption certificate and must complete an annual tax incentive survey. The exemption was originally set to expire June 30, 2024, but ...

As of January 1, 2017, the gross proceeds of sales or gross income derived from a contract to provide and install a solar energy device are now taxable under the State of Arizona"s transaction privilege tax statute (see Arizona Revised Statutes Section 42-5075.B.13). Alternative Fuel and Alternative Fuel Vehicle (AFV) Use Tax Exemption. Arizona use taxes do not apply to natural gas or propane used in an AFV, AFVs converted to operate on alternative fuels, or the equipment used to convert a diesel vehicle to an AFV.
