Average cost of solar system in florida

As of October 2024, the average solar panel system costs \$2.13/W including installation in Orlando, FL. For a 5 kW installation, this comes out to about \$10,668 before incentives, though prices range from \$9,068 to \$12,268. After the federal tax credit, the average price drops by 30%.

In Florida, the average cost for a 5 kW solar panel system is around \$11,057. Once you factor in the 30% credit, the cost of a solar panel system in Florida comes down to \$7,740. When you file your taxes, you can claim this incentive as a credit towards your federal tax bill.

The cost of solar panels in Florida (2024) Updated Oct 22, 2024. You'll pay an average of \$10,711 to install a 5 kilowatt solar panel system in Florida, before incentives. The federal investment tax credit (ITC) lowers that price by 30% of all your solar equipment and installation costs.

As of January 2022, the average cost of solar in the U.S. is \$2.77 per watt. This comes out to \$24,930 for a 9-kilowatt system before federal tax incentives, so the net cost of a 9-kW solar energy system would be \$18,448. You'll probably save anywhere from \$28,000-\$120,000 over 25 years by going solar. Solar panels are just 12% of the total cost of a solar panel installation.
