



Building permit for solar panel installation

Do you need a permit to install solar panels?

Generally, local governments require a homeowner's solar installer/contractor to obtain a permit for rooftop panels before they can be installed. After the PV system is installed, a professional from the local government will inspect the new array to ensure all building, electrical, and safety codes have been followed.

How do I get an electrical permit for a solar PV system?

Complies with SFFD AB 5.12 Energy Storage Systems in R-3 Occupancies. Go to step 3C - Online Electrical Permit to apply for an instant electrical permit from DBI for your solar PV system if your project meets all the following criteria: Is 4KWdc and under. (Engineered plans are required at time of inspection.)

Do I need a permit for a rooftop solar installation?

Permit requirements can also vary between rooftop and ground-mounted installations. If you're installing a large ground-mounted solar installation, you may need to participate in a land use review, but you may not be subject to building or structural permits required for rooftop installations.

What is solar permitting & inspection?

Solar permitting and inspection refer to two processes that need to happen before a solar array can receive permission to interconnect to the grid and start producing electricity. Generally, local governments require a homeowner's solar installer/contractor to obtain a permit for rooftop panels before they can be installed.

Do I need a permit expeditor to install solar panels?

A permit expeditor can help ensure that you include the necessary information to get approved. Next, you can purchase and install your solar panels. Take the electrical diagram of the solar panel during installation because you'll need it when applying for your permit,

How much does a solar permit cost?

The cost of a permit varies depending on the municipality in which you live. In most cases, the fees are very reasonable. For example, a permit to install solar panels on a residential property in the city of Los Angeles costs \$39.

All solar PV systems that are proposed on a structure other than a single-family home or duplex require an Electrical Permit with plans. All ground-mounted solar PVs located five feet above the ground, commercial solar PV with structural or projects requiring building modifications will need to submit online for a Building Permit.
