How much does a solar panel cost?

Less efficient polycrystalline panels are typically cheaper at \$0.75 per watt, putting the price of a 400-watt panel at \$300. The cost of a solar panel also depends on how you buy it. If you purchase through a full-service installer, you will likely get a lower price for each panel than buying them individually from a retail store.

How much does a 5 kilowatt solar system cost?

The average 5-kilowatt (kW) solar panel system is \$14,210 before considering any financial incentives. However, a typical American household needs a system closer to 10 kW to adequately power their home, which costs \$28,241 in 2024. That price effectively drops to \$19,873 after considering the full federal solar tax credit.

How much energy does a solar system cost?

Before solar, this represents the average utility rate over the next 20 years, assuming annual rate hikes between 3-5% (based on location). After solar, this is essentially your lifetime energy cost divided by the total production of your system. Here's how that looks for the example system above:  $\$45,102 / 242,483 \text{ kWh} = 18.6 \text{ kWh}$

How much does a solar inverter cost?

**Inverter:** A solar inverter converts the generated DC electricity into AC electricity that can be used to power your home. The cost of an inverter depends on its size and efficiency, but these devices typically cost between \$1,000 and \$3,000. **Mounting system:** This is what holds rooftop solar panels in place.

How much does a home solar installation cost?

The faster the cost of electricity increases, the shorter your payback period and the greater your savings will be. Lower solar prices also drive shorter payback periods. Ten years ago, a home solar installation cost \$3.60/W according to the National Renewable Energy Laboratory. That's 31% more than what we see on EnergySage right now.

How much does a 6-8 kW solar system cost?

Typically, a 6-8 kW system--suitable for an average 2,000-square-foot home--will cost between \$15,000 and \$22,500 before applying any incentives. However, after applying the 30% federal solar tax credit, the cost can drop significantly to between \$10,500 and \$15,750.

For example, the cost of solar panels for a 2,500 square foot home would be \$28,750 before incentives and \$20,125 after the 30% tax credit.  $2,500 \times \$11.50 = \$28,750$ . While this method provides a quick-and-dirty estimate for the cost of solar panels, solar systems are sized based on electricity consumption -- not the size of your home.
