What are energy storage requirements?

1.1 These requirements cover an energy storage system(ESS) that is intended to receive and store energy in some form so that the ESS can provide electrical energy to loads or to the local/area electric power system (EPS) when needed. Electrochemical, chemical, mechanical, and thermal ESS are covered by this Standard.

### What is the energy storage standard?

The Standard covers a comprehensive review of energy storage systems, covering charging and discharging, protection, control, communication between devices, fluids movement and other aspects.

### Does industry need energy storage standards?

As cited in the DOE OE ES Program Plan, "Industry requires specifications of standards for characterizing the performance of energy storage under grid conditions and for modeling behavior. Discussions with industry professionals indicate a significant need for standards ..." [1, p. 30].

### Do energy storage systems need a CSR?

Until existing model codes and standards are updated or new ones developed and then adopted, one seeking to deploy energy storage technologies or needing to verify an installation's safety may be challenged in applying current CSRs to an energy storage system (ESS).

### What are energy storage systems?

Energy storage systems (ESS) are gaining traction as the answer to a number of challenges facing availability and reliability in today's energy market. ESS, particularly those using battery technologies, help mitigate the variable availability of renewable sources such as PV or wind power.

#### Do electric energy storage systems need to be tested?

It is recognized that electric energy storage equipment or systems can be a single device providing all required functions or an assembly of components, each having limited functions. Components having limited functions shall be testedfor those functions in accordance with this standard.

Where energy storage system input and output terminals are more than 1.5 m (5 ft) from connected equipment, or where the circuits from these terminals pass through a wall or partition, the installation shall comply with the following: 1. A disconnecting means shall be provided at the energy storage system end of the circuit.

Energy Storage Systems are structured in two main parts. The power conversion system (PCS) handles AC/DC and DC/AC conversion, with energy flowing into the batteries to charge them or being converted from the battery storage into AC power and fed into the grid.
