What is the impact of energy storage system policy?

Impact of energy storage system policy ESS policies are the reason storage technologies are developing and being utilised at a very high rate. Storage technologies are now moving in parallel with renewable energy technology in terms of development as they support each other.

What are energy storage policies?

These policies are mostly concentrated around battery storage system, which is considered to be the fastest growing energy storage technology due to its efficiency, flexibility and rapidly decreasing cost. ESS policies are primarily found in regions with highly developed economies, that have advanced knowledge and expertise in the sector.

How do ESS policies promote energy storage?

ESS policies mostly promote energy storage by providing incentives,soft loans,targets and a level playing field. Nevertheless,a relatively small number of countries around the world have implemented the ESS policies.

In 2020-2021, in response to the COVID 19 pandemic, China has committed at least USD 96.75 billion to supporting different energy types through new or amended policies, according to official government sources and other publicly available information.
