Do energy storage systems need a CSR?

Until existing model codes and standards are updated or new ones developed and then adopted, one seeking to deploy energy storage technologies or needing to verify an installation's safety may be challenged in applying current CSRs to an energy storage system (ESS).

What are the NFPA standards for energy storage systems?

Two of the most notable standards in the United States are Underwriters Laboratories (UL) 9540 (Standard for Energy Storage Systems and Equipment) and National Fire Protection Association (NFPA) 855 (Standard for the Installation of Stationary Energy Storage Systems).

What are the guidelines for battery management systems in energy storage applications?

Guidelines under development include IEEE P2686 "Recommended Practice for Battery Management Systems in Energy Storage Applications" (set for balloting in 2022). This recommended practice includes information on the design, installation, and configuration of battery management systems (BMSs) in stationary applications.

What is a stationary battery energy storage (BES) facility?

A stationary Battery Energy Storage (BES) facility consists of the battery itself, a Power Conversion System (PCS) to convert alternating current (AC) to direct current (DC), as necessary, and the "balance of plant" (BOP, not pictured) necessary to support and operate the system. What if the energy storage system and component standards are not identified?

A pumped-storage plant works much like a conventional hydroelectric station, except the same water can be used over and over again. Water power uses no fuel in the generation of electricity, making for very low operating costs. Duke Energy operates two pumped-storage plants - Jocassee and Bad Creek.

Table 1 explains performance evaluation in some energy storage systems. From the table, it can be deduced that mechanical storage shows higher lifespan. Its rating in terms of power is also higher.
