A lithium battery label or sticker is a mandatory requirement for all lithium batteries being transported. This label or sticker must clearly indicate that the package contains lithium batteries.

The introduction of the telephone number requirement for lithium battery labels initially left many shippers and carriers puzzled. There was uncertainty regarding its similarity to the 24-hour telephone number requirement in many countries, however, neither the UN nor national regulations explicitly stated that this number needed to be available around the clock.
