If your house is worth \$300,000, and you install solar panels with a total value of \$20,000, a property tax exemption would keep the assessed value of your house at \$300,000, not \$320,000. In most cases, you will need to apply for a property tax exemption, sometimes before the installation of your solar panels.

Under these solar financing agreements, a solar company installs solar panels on your home for no money down (hence, the misleading use of the word "free"), and you then either pay a monthly rate for the clean energy those panels produce, or you pay to rent the panels rather than paying for the energy they generate.
