

## Italy singapore energy storage enrollment

Singapore's First Utility-scale Energy Storage System Through a partnership between EMA and SP Group, Singapore deployed its first utility-scale ESS at a substation in Oct 2020. It has a capacity of 2.4 megawatts (MW)/2.4 megawatt-hour (MWh), which is equivalent to powering more than 200 four-room HDB households a day.

Quick background. Although Singapore has one of the most reliable electricity grids in the world, However, as Singapore looks to renewable energy and power imports to transition to a low-carbon energy system, and moves towards the electrification of its transport system, it is increasingly vital to ensure that its grid infrastructure remains stable and resilient.

Built across two sites on Jurong Island, our ESS enhances Singapore's grid resilience by mitigating the impact of solar intermittency as the republic progresses towards achieving its 2030 solar target of at least 2GWp and energy storage systems deployment of 200MWh beyond 2025.

Italy"s grid-scale energy storage market is set to be one of Europe"s busiest this year, with some 2.6GW/8.9GWh set to come online according to LCP Delta. Large-scale BESS are set to capitalise on significant opportunities in the capacity market, ancillary services and renewable load shifting.
