Customers who purchased HVAC equipment prior to July 1, 2021 had 180 days to submit their application to New Jersey's Clean Energy Program and that window has now closed.

There are currently four solar incentives available to homeowners in New Jersey. The first solar incentive is the investment tax credit (ITC), which currently allows you to deduct 30 percent of the cost of your solar energy system from your taxes. The second incentive is the Solar renewable Energy Certificate (SREC) program, followed by sales tax exemption and property tax exemption.

The rebate from the New Jersey Clean Energy Program will vary depending on which water heater you invest in, but homeowners can receive up to \$800 (and even more in some cases) Heat Pumps. The New Jersey Clean Energy Program calculates rebates for heat pumps based on three rating factors: the HSPF, EER, and SEER.

Purchasers of energy storage systems in Colorado will receive a tax credit equal to 10% of the purchase price. The tax credit is imposed at the point of sale; the buyer receives a 10% discount, while the seller will apply to the government for the credit.
