AFREC"s energy balance 2020 show that the total primary energy supply was 170 ktoe. Biomass (firewood and charcoal) is used heavily for cooking purposes. There is no oil refinery. As a result, all petroleum products including jet fuel, gasoline and kerosene have to be imported. The fuel comes mostly from an Angolan supplier that has an effective monopoly.
