With SN Power, Scatec also strengthens its position as a frontrunner in renewable energy and as a partner for governments and other stakeholders. In 2020 SN Power reached revenues of NOK 1,562 million (1,766), EBITDA of NOK 1,092 million (1,149) and Cash Flow to Equity of NOK 477 million (541), measured on Scatec's proportionate basis.
