Are energy storage codes & standards needed?

What is a safe energy storage system?

Does industry need energy storage standards?

As cited in the DOE OE ES Program Plan, "Industry requires specifications of standards for characterizing the performance of energy storage under grid conditions and for modeling behavior. Discussions with industry professionals indicate a significant need for standards ..." [1, p. 30].

What is energy storage system (ESS)?

Energy storage system (ESS) is playing a vital role in power system operations for smoothing the intermittency of renewable energy generation and enhancing the system stability.
