What is APG's largest solar + storage investment?

APG's largest single solar +storage investment to date is Gemini, which is expected to generate enough clean energy to power more than 400,000 homes during peak periods and displace 1.5 million metric tons of CO2 annually once complete and operational in 2023.

What is the largest solar + storage project in the US?

The Gemini solar +storage project is currently the largestunder construction in the US. It recently closed a record breaking US\$1.9 billion tax equity and debt financing led by Bank of America, Truist, KeyBanc, MUFG, and NORD/LB. Truist Securities advised Quinbrook and Primergy on the transaction.

Will shell New Energies buy Savion?

Clean energy division Shell New Energies announced the move today in a press release issued on the Cision PR platform, but did not specify how much the acquisition will cost or how the deal will be structured. Who owns BW solar?
