The federal solar tax benefits lets you claim 30% of the total cost of your solar power system as a credit you can use to offset your tax liability. The federal ITC is the largest solar tax credit available to Illinois residents, allowing them to claim 30% of the cost of their rooftop solar installation as a tax credit.
