

Are energy storage codes & standards needed?

Discussions with industry professionals indicate a significant need for standards..." [1,p. 30]. Under this strategic driver, a portion of DOE-funded energy storage research and development (R&D) is directed to actively work with industry to fill energy storage Codes &Standards (C&S) gaps.

Does industry need standards for energy storage?

As cited in the DOE OE ES Program Plan,"Industry requires specifications of standardsfor characterizing the performance of energy storage under grid conditions and for modeling behavior. Discussions with industry pro-fessionals indicate a significant need for standards ..." [1,p. 30].

Do energy storage systems need a CSR?

Until existing model codes and standards are updated or new ones developed and then adopted, one seeking to deploy energy storage technologies or needing to verify an installation's safety may be challenged in applying current CSRs to an energy storage system (ESS).

What is a solar energy storage system?

The code includes systems where equipment and components collect, convey, store and convert the sun's energy for a purpose, including but not limited to service water, pool water and space heating and cooling as well as electrical service. Do electric energy storage systems need to be tested?

It is recognized that electric energy storage equipment or systems can be a single device providing all required functions or an assembly of components, each having limited functions. Components having limited functions shall be tested for those functions in accordance with this standard.
